JUDGES APPROVE OF DIRECT PROFESSIONAL ACCESS TO BARRISTERS

The cost advantages of using barristers without a solicitor have been judicially recognised. In *Agassi v Robinson* [2005 EWCA Civ 1507], tennis star Andre Agassi employed expert tax consultants Tenon, who in their capacity as members of the Chartered Institute of Taxation directly instructed barristers under the Bar Council’s direct access scheme to conduct Agassi’s case against the Revenue. The Court of Appeal said:

“It is obviously desirable that members of organisations such as the Chartered Institute of Taxation who are responsible and skilled persons should be encouraged to use...the arrangements by which they may instruct barristers direct...as a new and a better way of providing advocacy services. The advantages of these arrangements are clear. These persons have specialist expertise in the field of tax law, often far exceeding that of solicitors...[T]he fees charged by a firm of solicitors for the work done...might well have been three times as high”.
